

Greater Suburban Mixed Doubles Travel Team

2008/09 Rules

Dates: October 3, 2008 – May 8, 2009

Level of Play:

	Four Courts
Court 1 combined rating:	9.0
Court 2	8.0
Court 3	8.0
Court 4	7.0

League Time: Match start times scheduled by host club. *Play will be limited to 2 hours -- NO EXCEPTIONS.*

Eligibility: **All players must be current members of the club they play for and at least 21 years old.**

Format: Teams should be positioned in order of strength.
Warm-ups limited to 15 minutes after start time.

Individual matches will consist of three sets, or until time has expired. A 12-point tiebreaker will be played in any set that goes to six games all.

Absolutely no coaching will be allowed after the matches begin.

Scoring: Each set will equal one point.

Time Limit Scoring: If a set is even, the point is split. If a set hasn't started, the point is split. If a team is ahead by 2 games, that team wins the point. If a game is not completed, it does not count.

Results: Scores must be entered by Tuesday following each match.

Default: Fifteen minutes late - no warm-up; 16 through 30 minutes late - loss of first set; over 30 minutes late - loss of match.

Defaults: **If a match must be defaulted, please contact the team coordinator of the opposing club to notify them as soon as possible, so the teams can be informed of the default. If you leave a message, please follow through to confirm that the coordinator got your message or call the club to make sure the players are informed of the default.**

A team may cancel a match 24 hours in advance without charge. Teams who fail to cancel 24 hours in advance or who do not show will be charged up to \$50/court if the Club is unable to re-sell the court time. If the court time or part of the court time is re-sold, the team will only be charged for the court time that is not sold.

Awards: A travel plaque will be awarded to the team with the most wins at the end of the season. If two teams are tied at the end of the season, first place will be determined by the play off match.

League Fees: Each team captain will pay the host club \$144/\$18 per player for four courts prior to each match. **This fee includes pizza and pop after the matches.**

Each club will pay Heritage Tennis Club a \$65 league fee prior to the 2008/09 season.

Miscellaneous: The schedules will be played as they are printed. **Matches are not to be postponed or canceled unless there is inclement weather.**
